TERMS AND CONDITIONS

Article 1: E-ticket availability

E-tickets will be available to download free of charge exclusively from the Monte-Carlo Television Festival's website: www.tvfestival.com.

The Festival's management team will use its social-networking channels to publicly announce when e-tickets are available to download.

Article 2: Conditions of entry

Entry to events is subject to event opening hours as indicated on e-tickets. Entry to public events will not be possible without an e-ticket.

Each e-ticket is valid for one person only.

To access the ceremonies, the minimum age is 10 years old (accompanied by their parent).

Article 3: Availability of places

Places are limited.

If all seats are filled, e-tickets do not guarantee entry to public events or the Festival's Official Ceremonies.

Only people with an #OMG Card will have guaranteed access to events.

Article 4: Clothing requirements

All public guests must wear appropriate clothing; failure to do so may result in guests being refused entry.

Article 5: Exclusion from an event

Any inappropriate verbal or physical behaviour that jeopardises or threatens to disturb an event will result in a guest's immediate exclusion.

Article 6: Consent for use of likeness

Guests give permission for the organiser to use any images of them taken during the Festival and for these to be featured in any promotional activities related to the Monte-Carlo Television Festival, without this use requiring compensation of any kind.

Article 7: Cancellation

The Organising Committee reserves the right to amend or cancel the Festival programme including, signing session, Meet and greet, public screening and special events without justification and without being liable for damages of any kind.

Article 8: Reproduction and violation of intellectual-property rights

Any reproduction or sale of an e-ticket is expressly forbidden, and may give rise to exclusion and legal proceedings. Any attempted fraud will result in a guest's immediate exclusion.

Article 9. RESPECT OF SANITARY MEASURES

Respect of the Festival sanitary instructions indicated on the website www.tvfestival.com is mandatory. Non-compliance will result in the immediate exclusion of the participant.

Article 10: Data Protection

The Monte-Carlo Television Festival undertakes not to disclose information provided by Participants to third parties. Such information shall only be used by its internal departments to process registrations or send information emails.

In compliance with Article 14 of the Monaco Act of Law dated May 25, 2018, the Participant has a right to access modification, correction and deletion of the latter's personal data. To do so, simply make your request online or by letter specifying your surname, first name and address.

In all events, the Participant declares that he/she is aware of Internet characteristics and limits, in particular with respect to technical performances, response time required to access, query or transfer data, as well as risks inherent to communications' safety.

It is expressly agreed that, except for obvious error by Monte-Carlo Television Festival, proved by the User, data stored in the Monte-Carlo Television Festival information system is valid evidence of orders placed by the User. Computer data and emails exchanged between the Participant and our services constitute valid evidence, and are admissible under the same conditions and with the same evidential value as any document which may be drawn up, received or filed in writing.

For the purposes of fulfilling the participation contract, all or some of this personal data may be:

* Communicated to other Participants, who may be located anywhere in the world, in order to enable them to prepare for the event and schedule their business appointments. In this regard, the Participants undertake not to use such data for any other purpose. The Organiser reserves the right to enjoin nuisances caused by such use by any means.

* Communicated to third parties that have entered into contracts with the Organiser, in particular the Organiser's representatives, service providers and partners, which may be located anywhere in the world.
